

BRIEF HISTORY

The school has an interesting history and came into being as a result of earnest efforts of Late Sh. Narayan Dass Ji, Sangathan Mantri Vidya Bharti Uttar Kshetra, comprising the states of Delhi, Haryana, Punjab, H.P and J&K. Since long, he desired to have a residential school in the SHIVALIK HILLS. He persued the Ministry of Defence in 1984, for the permission of a school at DAGSHAI CANTT. as there was a building owned by Hindu Shiksha Samiti, Kurukshetra lying vacant, but the permission was not granted by the concerned authorities, and therefore, the idea was postponed. He, however, continued to pursue the matter and ultimately, when in the year 1993, he put forth the proposal before the working committee of SARVHITKARI SHIKSHA SAMITI, CHANDIGARH the same was accepted by the SAMITI. The SARVHITKARI SHIKSHA NIKETAN was started at DAGSHAI CANTT in April, 1993.

Sh. Madan Jindal, S/o Sh. Rameashwar Dass Ji went to Chandigarh to enquire about the health of Sh. Narayan Dass Ji when he was ailing seriously in his old age. Sh. Narayan Dass Ji expressed his desire to him that the school be taken over by the Jindal Charitable Trust. A piece of land measuring about 16 Bighas was purchased on Barog Bye Pass road near Kumarhatti, in Distt. Solan on National Highway-22 and construction of the building itself, on an area of 4 Bighas, was started in 1997.

LOCATION

Sarvhitkari Shiksha Niketan is about 2 Km. from Kumarhatti, on Barog Bye Pass-Road. It is 55 kms from Shimla the Capital of H.P. and 55 kms from Chandigarh, the Capital of Punjab & Haryana. The school is situated between the beautiful green hills surrounded by salubrious pine trees. The situation thus itself provides natural environment and invigorating climate with distinct warm and cool seasons having the following temperatures (Average).

CHARACTERISTICS OF THE SCHOOL:- The school has a huge multi-storey building with well furnished Class Rooms, Music Room, Indoor Play Rooms, Assembly Hall, well equipped Science Laboratories, Mathematics Laboratory, Computer Laboratory and a Library as per C.B.S.E. norms.

The Computer Laboratory is equipped with 20 (Twenty) Computers at present. Computer Science is Compulsory for all classes.

Besides providing excellent education, the students are given ample opportunities to take part in co-curricular activities such as cultural, sports, drawing and painting competition right from in the school, inter schools to national level.

LIBRARY

The school has an excellent library for the students with a 'Reading Room' in the library itself. The library is well stocked with books covering varied spheres of activities and tastes. The process of adding more books is in progress. Each student is allowed to borrow two books at a time.

The school also subscribes important magazines and newspapers to help the students to keep themselves updated on national & international events.

HOUSES

All students of the school have been divided into Three Houses:'SHIVALIK, VINDHYACHAL & HIMALAYA' each having a captain and a vice captain. To develop a spirit of healthy competition in academics, sports and other co-curricular activities, inter house competitions are organized on every Saturday.

Monthly display board competitions are conducted on a particular topic covering all spheres of activities.











> SPORTS FACILITIES

"SARVHITKARI SHIKSHA NIKETAN" is the only school in the area with a big playing hall/auditorium having all necessary facilities for games like Table-Tennis, Basketball, Volleyball, Badminton, Kho-Kho, Kabbadi, Wrestling and Athletics. The Badminton court is a closed one. Students can also enjoy by playing the games of Chess, Carrom & Ludo. Regular P.T./ Yoga in the morning and games in the afternoon are compulsory for all the residential students. Yoga and Karate classes have also been started in the school. The school is also planning to start Skating and Gymnastics in the near future.

CO-CURRICULAR ACTIVITIES

Declamation, Elocution and Extempore Speaking Contests, Debates, Dramatics, Essay Writing, Art & Craft, Painting, Music, Dance, Picnic & Trekking are regular features of co-curricular activities.

→ ADMISSION/CLASSES

After the registration, syllabus for the entrance test will be sent to the parents. Entrance test for admission is conducted in general English, Mathematics and Science of a class lower than that in which admission is sought. Date and time for the test will be notified later on. Interview is held to check general behaviour of the child. Currently, SARVHITKARI SHIKSHA NIKETAN is having classes from Nursery to X which will be upgraded to XII standard in the near future.

EXCURSIONS

To give a change to the environment of the students, they are taken out on picnics twice a month. On the **2**nd Sunday of the month, they are taken out for trekking at a distance of 25 kms from the school campus and on the **4**th Sunday of the month they are taken out on a long trip approximately 50-100 kms. or more than that. Parents may not, therefore, call their wards on **4**th Sunday of the month.

→ MESS

Sarvhitkari Shiksha Niketan has its own mess. A fully balanced vegetarian diet is provided to the students. Non-Vegetarian food is not allowed in the hostel. The menu is framed in consultation with the residential students.

SCHOOL DIARY

Every student is provided with a school diary which contains C.C.A.calendar, examination schedule, evaluation and promotion criteria, dress and other rules.











→ VACATIONS

- (i) **SUMMER BREAK**: School closes for 10 Days on 1st & 2nd week of June.
- (Ii) **DIWALI BREAK:** School closes for 10 Days, two or three days before Diwali.
- (iv) WINTER BREAK: School closes for 45 days but New & Old 10th classes will be called for camp classes after one month.

NOTE:- Specific dates will be mentioned in the school diary.

→ HOSTEL

Sarvhitkari Shiksha Niketan provides a comfortable hostel accommodation (for 100 students at present) with spacious dormitories. Each student is given a separate cot with mattress & a cupboard. Arrangements for hot water bath & laundry are also available. Other articles like blanket, pillow & quilt have to be brought by students themselves. They should have their own cosmetics like soap, shampoo, oil, deodorant, tooth brush & tooth paste, shoe polish etc.

Students are not allowed to have any electronic equipments such as mobiles, radio, walkman, video games, stereo or any other instrument in the hostel. They are also not allowed to keep valuable things such as expensive wrist watches, costly shoes and jewellery with them.

Parents too are requested not to give any valuable thing or article or any cash to their wards, whenever visiting them. Loss of any expensive item or cash, if any, with the student, against rules of the school will be the personal responsibility of their ward. No correspondence in this regard will be entertained.

Parents can talk to their wards only on Sundays. In case of new students, parents can not talk to them for five weeks. During this period, they may, however, talk to the Hostel warden/tutor and enquire about the welfare of their ward & his adjustment etc. in the new environment.

Parents and duly authorised visitors are permitted to visit their wards only on third Sunday of the month.

The school has a very constructive & positive approach in the matter of entertainment to the students. The school has its own auditorium where films and the cultural serial like Ramayana /Mahabharata are screened once a week on Saturday, which inculcate Indian culture, values and tradition in the student. It is compulsory for the students to listen the news daily.











→ PERSONAL ACCOUNT

Parents are, however, required to deposit Rs. 8000/- annually along with the fee in their ward's personal account. The necessary amount out of this deposit is given to the students as pocket money, when they go on trekking or picnics. Personal amount is accountable, at the end of session. If the amount is in excess, it is carried over to next session and if in deficit, the deficit amount is taken from the parent. The cost of dresses, books and note books etc. are also added to their personal account.

Students' birthdays, if desired, are celebrated with the arrangements by the school. The limit of the expenditure is not permitted to exceed a sum fixed by the school. Parents & relatives are advised not to send valuable gifts or any eatables on birthdays. Bournvita, Dry fruits & Ghee is allowed to be brought by the students. Students too are not allowed to bring eatables from outside the school, even other wise.



FOR HOSTLERS'

Parents/Guardians are requested to deposit the school fee (including Boarding & Lodging) in two installments as follow:

1st **Installment**: At the time of fresh admission or in the month of March, or which ever is earlier.

2nd Installment: In the month of August.

FOR DAY SCHOLARS'

Parents/Guardians are requested to deposit the school fee by the 10th of every month otherwise they will be fined.

NOTE:- If the fee is not paid in time, a fine of Rs. 10 per day will be charged from the student. In case of non payment after the above specified dates, the name of the defaulter shall be struck off from the rolls of the school.

EVALUATION SYSTEM

S.S.N. follows the continuous and Comprehensive Evaluation System as directed by the C.B.S.E. In this system the student will be evaluated on the basis of both scholastic and co-scholastic aspects of development, which helps in the over all development of the student.

→ PROMOTION RULE

Students will be promoted to next class only when they fulfill the necessary criteria of scholastic and co-scholastic areas as directed by CBSE i.e. atleast 'D' grade in scholastic area and must satisfy the minimum requirements in co-scholastic area. Otherwise 2 chances will be given to him / her to improve his / her grades.

WITHDRAWAL

Parents must give the Principal at least one months advance notice in written, if they wish to withdraw their child. Tuition Fee/Annual Charge will not be refunded. The Principal has the right to ask for the withdrawal of a child from the school at any time without assigning any reason. Students leaving the school on any account, must take their belongings with in one month of their leaving the school, after which no such claim shall be entertained.





GENERAL INSTRUCTIONS

Parents are requested to keep in view the following points:

1. They Must:

- (a) Specifically state in the application form submitted at the time of the admission of their ward, that neither their ward himself nor any member in the family is suffering from any serious or communicable disease.
- (b) Attend promptly to the school circulars regarding fees, leave, escorts, and progress reports and instructions, regarding attention to their wards' studies during vacation.
- (c) Do not ask for leave for their wards for attending weddings, other social or religious functions.
- (d) Ensure that their wards do not overstay after vacations or sanctioned leave and report back to the school on due date & time.
- (e) Do not visit the school except on fixed days and contrary to the timings & other instructions on the subject.
- (f) Observe rules for prior appointment i.e. to seek it either by writing or on phone to the concerned authority. They are requested to contact the Principal, whenever they happen to visit the school.
- 2. If any student is found guilty in damaging the school property disciplinary action will be taken against him/her and he/she may even be expelled from the hostel/School, keeping in view the gravity of the fault.
- 3. It is clarified that if any student meets with an untoward and unfortunate accident, while the students are being taken in the school bus or any bus or vehicle arranged by the school for any excursion/ picnic, trekking or while playing, the. school will not be held responsible in any manner whatsoever for such an accident/incident nor it shall be liable for any expenses for the treatment of any serious injury caused to the students. However, the school will ensure that the medical aid is given to such students by taking him/her/ them to the nearest available dispensary / clinic / hospital or private doctor but all the expenses will be chargeable to the parents for subsequent treatments.
- 4. Students will not be issued the school leaving certificate unless all dues are cleared.
- 5. Parents are requested to attend the parent teacher meetings to know the progress of their wards.
- 6. It is also added here that if any dispute on any account whatsoever arises, the same shall be liable to be proceeded in the jurisdiction of courts at Solan (H.P) or NABHA (Punjab)
- 7. Parents/Guardians are requested to co-operate with the school in maintaining its norms and traditions.
- 8. The school constantly endeavor to maintain proper educational environment & discipline for imparting education as a mission & not for making any income or profit.

Note: The school management has every right to amend the rules with or without prior information.
